- **the capital, interest and fee payment obligations of the debtor as indicated above by the debtor's option, arising from the Loan contract shall not be modified**, therefore, **the debtor shall be obligated to perform its payment obligations under the original contractual conditions**, and
- **the amount of any debt accumulated during the payment moratorium becomes due in one sum**, the Bank shall enforce its claim against the Debtor in accordance with the original terms of the Loan Agreement - without requiring of default interest.

In the name of the debtor, I/ We acknowledge that if the debtor would like to use the opportunity of payment moratorium as specified in the Moratorium Act, it shall be obligated to inform the Bank of the aforementioned intention in writing; and this change shall only be applied for the payments due after the receipt of the written notice thereof by the Bank.

In the name of the debtor, I / We undertake to send a duly signed hard copy of the present statement as soon as conditions permit, but no later than within 8 (eight) calendar days following the expiry of the emergency situation declared with regards to the coronavirus pandemic in Hungary.
